President's Report

David Rhodes

In my capacity as President, these preceding 12 months have been extremely rewarding for the Club. While there are many tasks and projects still underway, it's a credit to our members and current Board of Management for the achievements we've seen thus far. While we started the year exposed with no CTO or Club Captain, this enabled the Board to truly understand and identify our gaps, ensuring we have the right processes and support in place to reduce our risk exposure. As we were reviewing and identifying the gaps that needed to be filled, the Board of Management undertook the mammoth task of creating a four year Strategic Plan. It's fulfilling to see we had this unanimously endorsed by the Club Council earlier in the year which now gives a clear path of what future success looks like and where we need to focus to achieve these results. A by-product of this is we now have both the CTO and Club Captain positions filled with proactive and positive contributions aligned to our Strategic Plan.

Financially we're in a healthy position with a positive nett cashflow result from our operations that was supported through strong results we achieved within our fundraising, sponsorship and grant portfolios. We also need to acknowledge the continued success of our Supporters Club and their Board of Management team for the sustained support and congratulate them for their results within a highly unpredictable environment of hospitality and the contributions they are in turn able to donate. While North Burleigh maintains one of the state's largest junior programs our holistic membership base returned only marginal growth results and will be a continual focus in the next 12 months to ensure we grow aligned to our Strategic Plan.

Our patrolling season obligations and responsibilities were successfully fulfilled without any major incidents occurring while also receiving encouraging feedback from South Coast Branch on our significant improvement within our patrolling units. A huge thank you to all our patrolling members for continuing to give your time in this space, without it we simply wouldn't survive. The engagement across the Club continues to be really encouraging with the reframing of our communication with the conversations we have and the feedback we're receiving. Evidence to support this was the amazing turn out at the Club's Christmas party with over 30% of our membership base attending and the recent Working Bee further strengthening our One Club philosophy and goal of what's possible when we all work together. 30-40 of our members across all sectors of the club pitched in to help and it was wonderful to see the age gap diversity from our nippers as young as 8, to our more elder folk who are still very much young at heart all happy to do what they could. The sum of many has resulted in the club having a whole new look and feel.

COVID 19 continued to create and deliver uncertainties within the SLS movement and in a SLSQ process review, information presented to SLSQ's Board meant a decision was made to suspend the requirement for staff and volunteer members to be fully vaccinated by the 31st March 2022. It is now deemed as 'highly recommended' with its membership and staff to be fully vaccinated.

As our clubhouse redevelopment plans are refined, this means we're almost at the juncture where we are able to present to our members what the future of North Burleigh could look like. The timelines have been pushed out as a reflection to the due diligence and attention to detail that's being given to this opportunity, but more importantly ,ensuring that the Board are able to articulate what this means for our members. At the same time our new Operations Management restructure means we're able to continue maximising our efficiencies, maintaining greater office support to our Trainers and Educators, reducing lifesaving volunteers hours spent processing administration, so our members can choose to give their time where they enjoy it most.

President's Report contd.

A significant highlight within the Surf Sports season was that North Burleigh took out the Australian Title for the under 13-15 age group with an unofficial point score win, (SLSA currently don't officially provide a point score in this age category), however other Clubs circulated the point score tally via Live Heats results. Huge recognition to our current and previous coaches, Surf Sports Directors and JAC teams who have believed in and delivered on a 10 year plan for grass roots development. Watch this space in the next 5 years.

I've had the opportunity to meet with other Club Presidents, hierarchy within SLSQ and South Coast Branch members to further nurture new and existing relationships to continually better understand the SLS movement and how we can all win together. I continue to enjoy my tenure as North Burleigh's President and that membership for all of us, is a privilege and not a right. We are all temporary custodians of our Club which exists for the future generation of our members and we serve to leave our position whenever that time may be, one step closer to what success looks like to North Burleigh.

General

The Budget presented at the Annual General Meeting (19 June 2021) by the previous Board was approved by the incoming Board on the 7 July 2021 with no changes.

The following achievements/milestones were completed this season (in no particular order):

- A review of Chart of Accounts Codes and Classes was undertaken, and the budget was transitioned into the new format and loaded into Xero (online accounting system).
- The incoming Executive team successfully transferred to the CommBiz banking system and new accounts were setup. There were no changes to Credit Card limits.
- A review of the invoice approval process was undertaken. All invoice approvals are now managed directly in Xero (online accounting system). This process eliminates the requirement for emails and facilitates workflows directly within the system.
- A review of the office staff timesheet approval process was undertaken. All timesheet approvals are now managed directly in Xero (online accounting system). This process eliminates the requirement for emails and facilitates workflows directly within the system.
- The weekly transfer (setup by the previous Board) of \$1,076.76 to the Sinking Fund Account to cover building maintenance has continued. The weekly transfer (setup by the previous Board) of \$446.75 to the Future Provisions Account to cover solar repayments and rates has also continued. Other adhoc transfers are made as required (i.e., staff provisions and insurances).
- Various grant applications were secured with several others pending an outcome. The funds secured by these grants have gone towards critical lifesaving equipment, including rescue boards, tubes, first aid equipment, CPR training manikins, IRB fuel bladders and lifejackets.
- All merchandise and swimwear is now managed directly by the Juniors. A new online point of sale system was implemented which manages all payments and stock. The online payment system also allows payments to be linked online survey forms that require payments (i.e., camps, levy's, etc). The system allows all transactions to the tracked in a central location reducing manual reconciliation.
- As identified as an action item in last year's audit, a Delegation Policy was developed and approved by the Board.
- Cathie Wilshire, the Club's Administration Officer resigned in early January 2022 and Troy Draman, the clubs Office Manager resigned in early June 2022. All outstanding entitlements have been finalised and paid with no further costs to be incurred.
- A review of the Future Provision Account was undertaken, and a full reconciliation was completed.
- A review of GST application to levy payments was completed by the club accountants. The Accountants confirmed that the GST has been applied inconsistently across various levy's (Surf Sports, camp and State levies).

2021/22 Results

• The Club Auditor (Ian Barfoot) completed the annual audit in late May 2022 which was followed by a presentation to the Board in early June 2022. The Board has endorsed all financial statements for the year ending April 2022. The **Financial Report** is attached for reference.

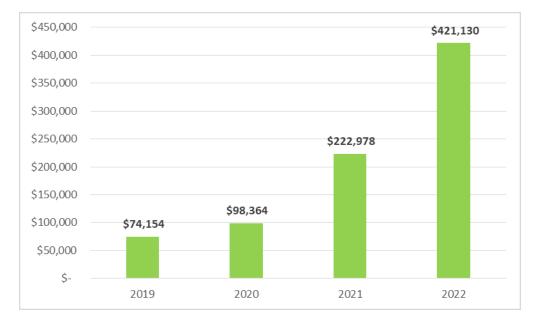

• A summary of Profit and Loss (including and excluding depreciation) is as follows:

The Club finished the financial year with a $\frac{268,330 \text{ surplus}}{268,330 \text{ surplus}}$ (excluding depreciation) and a $\frac{38,667 \text{ deficit}}{38,667 \text{ deficit}}$ (including depreciation).

The Club's cash position remains healthy and has steadily increased over the past 4 years with a $\frac{198,152}{(89\%)}$ increase from the prior year.



The Supporters Club continue to work hard in a difficult and evolving environment. Total contributions received from the Supporters Club was ~ \$427,000 which was in line with budget.

2022/23 Budget

The Board commenced budget planning in early February 2022 with all sector leads. Various workshops and reviews were completed with the Board endorsing the final budget in early June 2022. The **Budget** is attached for reference.

The budget is an operational budget and excludes any allowance for significant capital works. The budget is consistent with the strategic objectives in the approved Strategic Plan. A detailed breakdown of all budget items per sector has been developed. Key items include (in no particular order):

- Supporters' Club contributions are in line with the 2021/22 financial year
- IRB class has been removed and consolidated with Patrol Operations
- Income items (i.e. membership, sponsorship, grants, levy's and grants) are generally in line with the 2021/22 financial year
- Provision for patrol lunches and member recognition throughout the season
- Provision for regular repairs and maintenance of all operational gear and equipment

Director of Finance contd.

- Provision for the purchase of two (2) new IRB Motors (noting two new motors were purchases in April 2022)
- Allowance for two (2) fulltime staff to support the Surf Club's operational requirements
- Surf Sports coaching budget is generally, in line with the 2021/22 financial year
- All Aussies 2023 (Perth) expenses have been offset by fundraising initiatives
- Provision for regular general building maintenance. No allowance for any significant building works (i.e. roof, electrical switchboard roller doors)

The Budget for this financial year delivers a **\$**70,778 surplus (excluding depreciation). The weekly transfer of \$1,076.76 to the Sinking Fund Account will continue.

The Budget will be regularly reviewed throughout the season and adjusted as required.

Conclusion

I consider this Report, and the associated Financial Statements as presented to be correct and that they be accepted as a true and correct record of the Club.

As reported above, the Club is in a strong financial position as we enter the 2022/23 season.

The Club's liquidity ratio (current assets to liabilities) continues to improve and is currently sitting at **9.67 to 1** which is a significant improvement on the same time last year (**6.88 to 1**). The Club Auditor has advised a best practice of 2 to 1, therefore with a rate greater than the recommended minimum the committee has a high level of comfort that it can pay its debts as and when they are due and payable.

The Board will continue to pursue sponsorship opportunities and community partners. There has already been some great work completed in securing new long-term sponsors and reengaging with other long-term sponsors.

A key focus moving into the 2022/23 season is fundraising. The Board will continue to focus on maximising returns while trying to minimise resource impacts. Both fundraisers (200's Club and Nipper Ironmania) will continue next season with some minor changes to their delivery and timing. Other fundraising opportunities will be explored.

Although the Club has been extremely successful in securing several grants this season there are still a number of others that are being pursued. The Board will continue to review and peruse all grant opportunities.

Lastly thank you to David Rhodes and Andrew Hadden for their dedication to their roles as Club President and Secretary. Their commitment of time to our Club has been significant.

As a community we look forward to all working towards a successful summer ahead in 2022/23. I am also looking forward to working with the new team in the office. Please feel free to contact me directly with any questions.

Director of Lifesaving

The 2021/2022 patrol season has been a challenging one for North Burleigh SLSC for a number of reasons but ultimately a successful one. I would like to extend my thanks to all of the club members who have dedicated their time to patrolling our beach this season and ensuring that our mantra of "not one, not ever" continues to be upheld. The demands on volunteers to complete a successful patrol, from gaining and maintaining awards, to ensuring serviceable equipment, to compliance with policies and procedures, and finally the vigilance and skills required on the day, meant that everyone who patrols our beach shows a dedication and commitment that should be commended.

By far the greatest challenge the Club faces is maintaining and growing our active senior membership to ensure that the effort required to provide lifesaving services within our Club is spread among as many as possible. Special thanks must go to all the trainers within the Club as it is their tireless contribution that is critical to developing our patrolling ranks. This season has been one of transition as Steve Cooper finished his reign as Chief Training Officer. Steve's efforts over many years have been huge and no one person could be expected to fill his massive shoes. Thus, multiple people have stepped up to continue the good work with Danny Zerbst taking on the official title of CTO during the season.

We have also seen a significant contribution from Long Service members within the Club this year. Along with all the members who continue to actively patrol as Long Service members, we had a number of members who have answered the call and returned to patrol operations this year. The value of having experienced members on patrol cannot be understated and was just another factor in a successful year.

The weather over the past nine months has proven to be a significant challenge for the entire State. This, combined with the continuing impacts of COVID, has meant providing an enjoyable patrol experience has not been simple. I would like to especially thank all our Patrol Captains for their efforts in managing their patrols during the entire season. Managing diverse teams is no simple task and every Patrol Captain has worked hard this season to ensure our patrols are successful.

As well as impacting attendance and activities at our own beach, the significant weather events this season also saw Surf Life Saving resources called upon across the State to provide assistance to people away from the beach. In February two IRB crews, including gear, were sent to Brisbane provide as part of Queensland Fire and Emergency Services response to the flooding event that occurred. The crews were tasked with providing assistance to police, ambulance and SES crews in responding to incidents, as well as responding directly to requests for assistance from members of the public. The activities undertaken on the day demonstrate how transferrable the skills learned within Surf Life Saving are to other facets of life and the productive contribution all members can make to the community we live in.

Personally, I came into this position in the later half of the season and only did so on the back of the efforts that other members of the Board of Management had made during the main part of the patrol season. Special commendation must be made for the efforts of Andrew Hadden as he stepped in as acting Club Captain during the most difficult part of the year and ensured the season went as smoothly as possible.

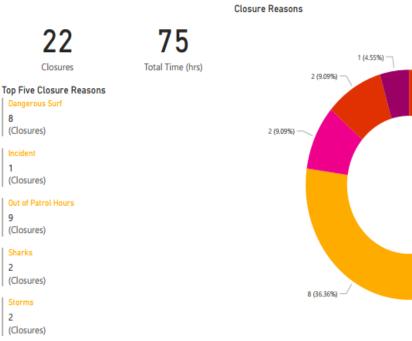

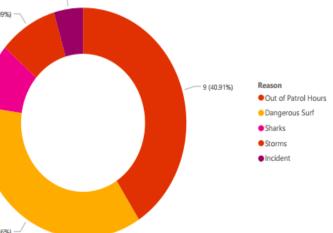

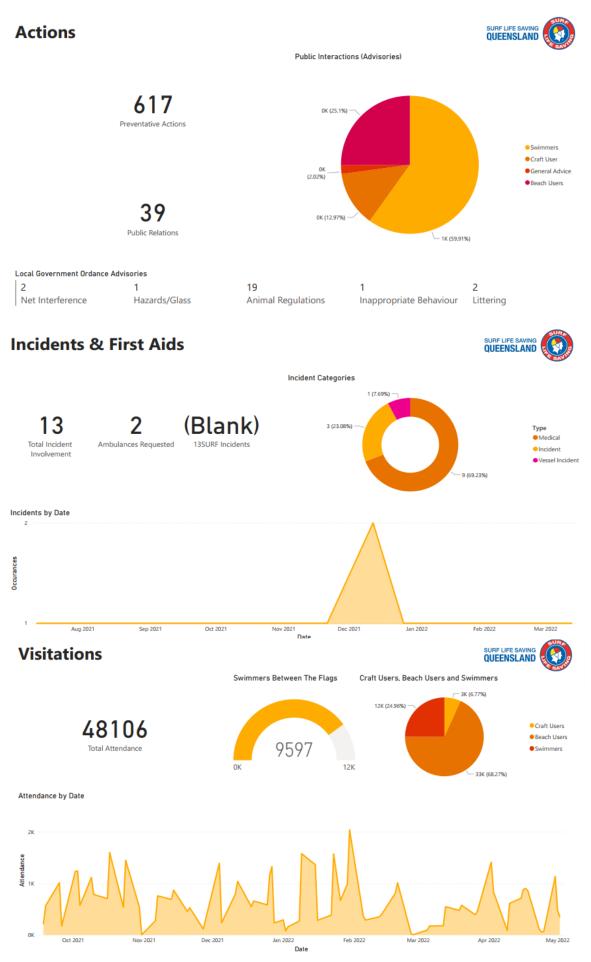
Beach Closures



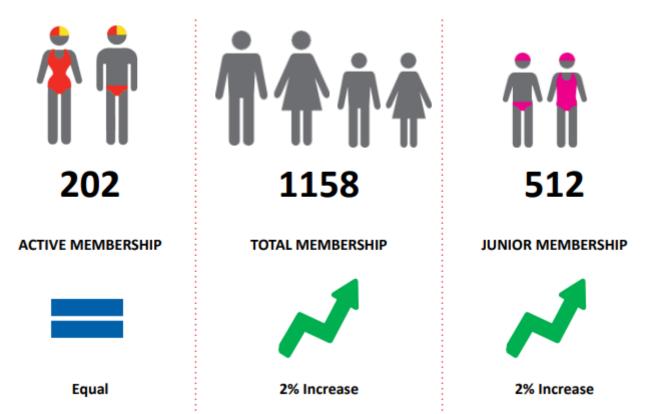

Throughout the 2021/22 season, the Board of Management has been busy re-framing the conversation with our members and working hard to redirect the focus & energy of members towards positive initiatives that will drive the Club forward.

Internally, the Board of Management has been re-energised and share a united focus for the future of our Club. With that said there have been some robust and challenging conversations and some strong debate on issues, all of which I believe is a reflection of a very healthy Board environment.

It is however quite refreshing to see all decision-making being made in the best interests of the Club and its members, then having an entire Management team who can support such decisions and work to drive them forward. - Major Sponsorship Packages secured with further opportunities under negotiation.
- Strategic Plan 2022-2026 developed and endorsed by the Club Council.
- Steering Committee established and significantly advanced considerations on a Club Redevelopment Proposal ready for member engagement, interaction and feedback (coming soon).
- Restructure of Club Operations (paid staff) to provide a model that is scalable with the growth and evolution of our Club.

Director of Surf Sports

Introduction

I am pleased to offer this Report to our members following my first season in the role of Director of Surf Sports. At the outset I would like to thank the current Board of Management for their ongoing support and aligned vision for the North Burleigh Surf Lifesaving Club and all its sectors.

It is important that I recognise the commitment of our Club sponsor, Realty Blue and our Surf Sports sponsors, Pacific Coast Plumbing, Holby Electrical and Gold Coast Oral and Maxiofacial Implant Surgery. A successful Surf Sports program requires critical funding and all support provided by our sponsors goes directly towards creating a better environment and experience for our competitors.

Junior Competition

While 2021/22 proved a challenging season due to continual weather events and carnival cancellations, our Juniors again lead the way in development and participation numbers in Surf Sports. Our under 8-10s were crowned as Branch Champions. Our Under 11-15s as Gold Coast City Titles Champions and Branch Champions. Further competition was limited due to weather/surf conditions and this unfortunately culminated in the cancellation of State Titles in February. I would like to take this opportunity to thank our Junior Coaches; Nicole Locke, Tim Walker, Britt Murray, Beth Puddey and Clifford Rodd for their continued efforts in the development of our Juniors, by far the leading program in the State.

Youth/Senior Competition

2021/22 was a significant growth year for our Youth/Senior group with the incoming Under 14s growing the squad to 30 plus members. This group was more fortunate with regards to competition; taking part in the Coolangatta Gold, Oceans 38 Series, Summer of Surf Series and ultimately Aussies (which for the first time ever, also included under 13s). Highlights of some of the early events would include; Ethan Callaghan (15) partnering with Dan Bowker to complete his first short course Coolangatta Gold. Podium finishes to Riley Rasmussen, Jai Murray, Jasmine Rayward and Bianca Rayward at various Summer of Surf events. Our under 14 girls consistently making finals as they raced up an age in 15s at all Oceans 38/Summer of Surf events and the ongoing development of the whole squad under the guidance of Head Coach Mike Murray, Josh Meyer and Adam Jeffery.

Ultimately it was Aussies where our group really had the opportunity show how far they have grown. With the inclusion of the under 13s, our Aussies Youth Squad numbered almost 50 strong and achieved results well ahead of expectations. 10 x Individual medals, 9 x Team medals and plenty of finals appearances saw North Burleigh at the top of the Youth Point Score table (even though SLSA don't officially announce a Youth Points Champion). These results were overwhelming to the Coaches and Surf Sports Committee, affirming our status as the leading Youth Development Club in the country. Our small group of under 17/19s preformed exceptionally well later in the week with finals appearances for Ethan Callaghan and Michaela Whitmee, and a couple of trips to the podium for Jasmine Rayward. This group will benefit massively next season as our current under 15s move up to join them. While our current stage of growth sees us light on for dedicated Opens competitors, it was great to see some of our Masters wind back the clock at Aussies with an outstanding highlight of Adam Jeffery and Tom Trembath Jnr placing 6th in the Open Men's Board Rescue.

Masters Competition

With the cancellations mentioned above, our Masters Competitors were essentially restricted to competing at Aussies this year. While the priority of this group is enjoyment and remaining active; there were some fantastic performances by Josh Meyer, Tom Trembath Jnr, Adam Jeffrey and Kirsty Jones that should be acknowledged. Great also to see the likes of BJ Miley and Peter Primo still making their way around the cans on the single and double ski.

IRB Racing

Unfortunately, due to light engagement, the decision was made to withdraw from competition this season. Accepting that our Racing Team was at the infancy of a rebuild; Coaches Adam Barbour, Russell Codlin and Team Manager Ben Cook have instead focused on the continual training of our patrolling Drivers and Crewies, with the hope of re-establishing this sector in the coming seasons.

Social Engagement

It was identified early in the season that social engagement was a critical component to connecting and retaining our Youth. As such we hosted multiple successful events through the season, including; Preseason Youth Development Camp (including military obstruction training at Canungra and a camp-out at the Club), the Virtual Molokai Challenge Endurance Paddle and BBQ, the Youth Christmas Break Up Party and Dinner, multiple School Holiday Craft Development Sessions and finally, State and Aussies Team dinners. It's important I recognise and thank Sean Haydock and the Supporters staff for always accommodating our squad during these events. As I prepare this document, over 30 of our 14-19 year old competitors are preparing to represent North Burleigh at the Gold Coast Youth Development Ball this coming weekend.

Club Commitments

It is pleasing to see the growth of our Youth/Senior competition group has aligned as the major growth area in Patrolling Sector. Current membership figures show that Cadet Members 13-15yrs have grown by 163% and Active Members 15-18yrs by 128%. The following figures have been derived from our current Patrol statistics;

Total Active Members Patrolled During Season 21/22 - 208 Active Competitors-58 (<u>25% of Patrol Group</u>) Total Hours Patrolled During Season 21/22- 4992hrs Hours by Active Competitors - 1720hrs (<u>35% of Patrol Hours</u>)

<u>Summary</u>

When taking on the role of Director of Surf Sports, I identified that our greatest opportunity was to convert our huge Nipper participation levels into a strong, successful senior squad. In particular, our highly engaged Youth group aged 13-17 and ensuring we keep them involved into their 20's. I believe this is best delivered by providing an environment that not only sees our members grow, develop and achieve as competitors; but one that also provides enduring friendships, social and community connection. This is a vision shared with Head Coach Mike Murray, who I would personally like to congratulate on another fantastic season of growth for North Burleigh. I believe the above report (coupled with the season's results), will show our greater membership that our Surf Sports sector is on a great path, that will continue to benefit our Club into the future.

Director of Junior Activities

To our wonderful Nipper Members, I am pleased to submit the following report for the 2021/22 season to the North Burleigh members.

As defined in the Club By-Laws, the role of the Junior Activities Committee (JAC) is to prepare junior members (Nippers) for their eventual transition to the marine and patrol environment of Surf Life Saving.

The JAC is conscious of its role to help grow both our Patrol and Senior ranks, and we believe this is best achieved through a balanced program that focuses on education, safety, growth, community and competition.

We continue to deliver our program in line with our North Burleigh P.R.I.D.E Principles; Participation, Respect, Inclusion, Development and Enthusiasm. This delivery has seen our Junior program make North Burleigh SLSC a destination for families looking for social engagement, value for money and Junior development.

Season 2021/22 saw the continuation of disruption due COVID-19 however the Club was still able to deliver a successful program to members. This coupled with quite a few extreme weather events had the Junior Committee on their toes regularly assessing conditions and making the necessary adjustments to the program. The number 1 priority was the safety and wellbeing of the children. This caused perhaps the most cancellations to a nipper season (nipper Sunday and competitions) in memory.

Memberships

Expected membership numbers were still a great unknown heading into the season, as it was not clear how the continuing impact of COVID-19 people would affect the return to activities.

North Burleigh signed up 515 nippers which was an increase of 49 members (from 466) or 11% growth and 347 Associate members which was an increase of 58 members (289) or 20% growth. This is a great outcome and a sign that junior sport and in particular North Burleigh Nipper program is growing and thriving.

It is great to see North Burleigh remain the largest Junior Activity program on the Gold Coast, if not the State and I look forward with the JAC and volunteers to continue the growth and success of North Burleigh Junior Program.

Approx. 60-85% of all Active Members in surf clubs are generated directly or indirectly from Junior Activities. It is the lifeblood of the Surf Life Saving movement.

The Junior Club has, in the past couple of seasons, delivered solid competitive numbers into the senior ranks which is a credit to the current and past committees and coaching panels. It's this development pipeline which lays the foundation for overall club success providing our next patrolling members and senior competitors.

- Find the scarce dollars to maintain our repairs and maintenance program and create a "sinking fund" to address these ongoing issues.
- Look for opportunities to grow the Surf Club footprint and conduct a refresh of the facilities.

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES Corporate Information

The financial report is for North Burleigh Surf Life Saving Club Inc as an individual entity, incorporated and domiciled in Australia. North Burleigh Surf Life Saving Club Inc is an association incorporated in Queensland under the Associations Incorporation Act 1981 (Qld) and is a registered charity under the Australian Charities and Not-for-Profits Commission Act 2012 (Cth).

Basis of Preparation

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 1981 (Qld) and the Australian Charities and Not-forprofits Commission Act 2012 (Cth). The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following Australian accounting standards have been applied in the preparation of these financial statements:

- AASB 101 Presentation of Financial Statements
- AASB 107 Statement of Cash Flows
- AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors
- AASB 1048 Interpretation of Standards
- AASB 1054 Australian Additional Disclosures

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Accounting Policies

a. Income Tax

No provision for income tax has been raised as the association is exempt from income tax under Section 50-10 of the *Income Tax Assessment Act 1997* (Cth). North Burleigh Surf Life Saving Club Inc is a Public Benevolent Institution (PBI) and has been endorsed by the Australian Taxation Office to receive tax concessions. Further, North Burleigh Surf Life Saving Club Inc is endorsed as a Deductible Gift Recipient (DGR).

b. Comparative Figures

When required by these accounting policies and/or the applied accounting standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year. When required, comparative information is reclassified where appropriate to enhance comparability.

c. Contributions

If and when North Burleigh Surf Life Saving Club Inc receives non-reciprocal contributions from the government or other parties for nothing or a nominal value the contributions would be recognised at the fair value on the date of acquisition upon which time an asset is taken up in the Statement of Financial Position and revenue in the Statement of Profit or Loss and Other Comprehensive Income.

d. Economic Dependence

North Burleigh Surf Life Saving Club Inc is dependent on the North Burleigh Surf Life Saving Supporters Association Inc for funds used to meet it's financial commitments. At the date of this report the committee members have no reason to believe the North Burleigh Surf Life Saving Supporters Association Inc will not continue to support North Burleigh Surf Life Saving Club Inc.

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES e. Critical Accounting Estimates and Judgments

The committee members evaluate estimates and judgments incorporated into the financial statements based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the association.

Key estimates

The estimate of the useful life of leasehold improvements, plant and equipment is reviewed at least annually to confirm that the remaining life of material assets is reflected on the asset register. There were no other critical accounting estimates to be considered by the committee members during the year or during preparation of this financial report.

Key judgments

The methods of depreciation are used to provide a consistent usage of the useful life of leasehold improvements, plant and equipment. The methods also allow, where required, for the leasehold improvements, plant and equipment to be fully written down at a specific point in time such as the end of the lease term. There were no other critical accounting judgments made by the committee members.

f. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the Statement of Financial Position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

g. Revenue

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Grant revenue is recognised in the Statement of Profit or Loss and Other Comprehensive Income when the association obtains control of the grant and it is probable that the economic benefits gained from the grant will flow to the association and the amount of the grant can be measured reliably.

Donations and bequests are recognised as revenue when received unless they are designated for a specific purpose, where they are carried forward as prepaid income on the Statement of Financial Position.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

Revenue from the rendering of a service is recognised upon the delivery of the service to the customers.

All revenue is stated net of the amount of goods and services tax (GST).

h. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, and other short-term highly liquid investments with original maturities of twelve months or less.

i. Inventories

Inventories are measured at the lower of cost and net realisable value.

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

j. Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, accumulated depreciation and impairment losses.

Leasehold improvements, plant and equipment

Leasehold improvements, plant and equipment are measured on the cost basis less depreciation and impairment losses.

In the event the carrying amount of leasehold improvements, plant and equipment is greater than its estimated recoverable amount, the carrying amount is written down immediately to its estimated recoverable amount and impairment losses recognised either in profit or loss or as a revaluation decrease if the impairment losses relate to a revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present (refer to Note 1o for details of impairment).

Leasehold improvements, plant and equipment that have been contributed at no cost, or for nominal cost, are valued at the fair value of the asset at the date it is acquired.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the association and the cost of the item can be measured reliably. All other costs are classified as repairs and maintenance and are charged to the Statement of Profit or Loss and Other Comprehensive Income during the financial period in which they are incurred.

Depreciation

The depreciable amount of all fixed assets including leasehold improvements are depreciated over their useful lives to the association using the rate and methodology disclosed in the table below commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the Statement of Profit or Loss and Other Comprehensive Income. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained surplus.

k. Trade and Other Payables

Trade and other payables represent the liabilities for goods and services received by the association during the reporting period that remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within thirty days of recognition of the liability.

I. Employee Benefits

Retirement benefit obligations - superannuation benefits

All employees of the association receive defined contribution superannuation entitlements, for which the association pays the fixed superannuation guarantee contribution (currently 10.0% [10.5% from 01 July 2022] of employee's average ordinary salary) to the employee's superannuation fund of choice. All obligations for unpaid superannuation guarantee contributions are measured at the (undiscounted) amounts expected to be paid when the obligation is settled and are presented as trade and other payables under current liabilities in the Statement of Financial Position.

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

I. Employee Benefits (continued)

Short-term employee benefits

Provision is made for the association's obligation for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly within twelve months after the end of the annual reporting period in which the employees render the related service, including wages, salaries, annual leave and long service leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled. The association's obligations for short-term employee benefits are presented as trade and other payables under current liabilities in the Statement of Financial Position.

Long-term employee benefits

The association only classifies employees' long service leave entitlements as long-term employee benefits as they are not expected to be settled wholly within twelve months after the end of the annual reporting period in which the employees render the related service. Provision is made for the association's obligation for long-term employee benefits, which are measured at the present value of the expected future payments to be made to employees. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departures, and are discounted at rates determined by reference to market yields at the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations. Upon the remeasurement of obligations for long-term employee benefits, the net change in the obligation is recognised in profit or loss classified under employee benefits expense.

The association's obligations for long-term employee benefits are presented as provisions under non-current liabilities in its Statement of Financial Position, except where the association does not have an unconditional right to defer settlement for at least twelve months after the end of the reporting period, in which case the obligations are presented as trade and other payables under current liabilities in the Statement of Financial Position.

m. Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

n. Leases

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are recognised as expenses on a straight-line basis over the lease term.

o. Impairment of Assets

At the end of each reporting period, the committee members assess whether there is any indication that an asset may be impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised immediately in profit or loss, unless the asset is carried at a revalued amount in accordance with another Standard (e.g. in accordance with the revaluation model in AASB 116). Any impairment loss of a revalued asset is treated as a revaluation decrease in accordance with that other Standard.

Where it is not possible to estimate the recoverable amount of an individual asset, the committee members estimate the recoverable amount of the cash-generating unit to which the asset belongs.

The committee members found no indication that any asset had been impaired.

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

p. Financial Instruments

Initial recognition and measurement

Financial assets and financial liabilities are recognised when the association becomes a party to the contractual provisions to the instrument. For financial assets, this is equivalent to the date that the association commits itself to either purchase or sell the asset (i.e. trade date accounting is adopted). Financial instruments are initially measured at fair value plus transactions costs except where the instrument is classified "at fair value through profit or loss" in which case transaction costs are expensed to profit or loss immediately.

Classification and subsequent measurement

Financial instruments are subsequently measured at fair value, amortised cost using the effective interest method, or cost. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amortisation process and when the financial asset is derecognised.

Financial liabilities

Non-derivative financial liabilities other than financial guarantees are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amortisation process and when the financial liability is derecognised.

Impairment

At the end of each reporting period, the association assesses whether there is objective evidence that a financial asset has been impaired. A financial asset or a group of financial assets is deemed to be impaired if, and only if, there is objective evidence that impairment as a result of one or more events (a "loss event") has occurred, which has an impact on the estimated future cash flows of the financial asset/s.
